Thank you for attending our 7th Annual Northeast Tarrant Transportation Summit. Our goal continues to be to inform the business owners, community leaders and citizens of Northeast Tarrant County regarding major transportation issues and plans to improve mobility in our area.

We have made great strides in recent years with transportation awareness and funding, including the passage of Proposition 1 and Proposition 7. Proposition 1 allows for a portion of the oil and gas tax revenues to be deposited into the general highway fund, while Proposition 7 dedicates a portion of the general sales and use tax as well as the motor vehicle sales tax to the general highway fund. However, with the fluctuation in oil and gas prices, as well as increased demand for transportation funding throughout the state, we must be increasingly vigilant in our efforts to improve transportation conditions in Tarrant County, and in turn, spur economic growth throughout North Texas.

This year's program theme is "Shifting Gears: Challenges and Opportunities in Regional Mobility" and includes programs and discussions on the ability of transportation funding measures to deliver on their promise, the impact of the Panama Canal on our region, and the status of transportation projects in Tarrant County. We are also privileged to have one of the nation's premier economists, Dr. Ray Perryman, who will discuss how to complete and advance transportation projects in our region can drive economic growth in the near future.

Dr. M. Ray PerrymanPresident and CEO of The Perryman Group

Dr. Ray Perryman is President and CEO of The Perryman Group, an economic research and analysis firm based in Waco, Texas. His firm has served the needs of more than 2,000 clients ranging from major corporations to small startups and from local communities to the federal government. Over the past 30 years, Dr. Perryman has helped recruit corporations providing tens of thousands of jobs through economic development work, resolved billion-dollar legal issues, and revamped public policy through impact assessments and other studies. His firm has measured economic impacts for corporate locations and expansions involving billions in investments, and his economic forecasts are used by corporations and government agencies alike.

Dr. Perryman has authored several books and more than 400 academic papers and has served as President of both the Southwestern Economic Association and the Southwestern Society of Economists. In the professional arena, he has authored more than 2,000 trade articles, publishes a subscription forecasting service and a monthly newsletter, writes a weekly syndicated newspaper column, hosts a daily radio commentary, and appears regularly on National Public Radio.

Dr. Perryman holds a BS in Mathematics from Baylor University and a PhD in Economics from Rice University as well as an honorary doctorate from the International Institute for Advanced Studies. He has held numerous academic positions in his career including 10 years as Herman Brown Professor of Economics and five years as University Professor and Economist-in-Residence at Baylor University, as well as five years as Business Economist-in-Residence at Southern Methodist University. His current academic roles include Senior Research Fellow of the IC2 Institute at the University of Texas, and Institute Distinguished Professor of Economic Theory and Method at the International Institute for Advanced Studies.

Michael Morris has served in the Transportation Department of the North Central Texas Council of Governments (NCTCOG) since 1979.

After working as a Transportation Planner, Senior Transportation Planner, and Assistant Director of Transportation, Michael became Director of Transportation in 1990. His responsibilities as director include managing the overall transportation activities of NCTCOG, carrying out the transportation policies of the NCTCOG Executive Board and Regional Transportation Council, and managing the implementation of rules, regulations and responsibilities of federal and state government.

Morris is a member of the Association of Metropolitan Planning Organizations, the Institute of Transportation Engineers, the American Society of Civil Engineers, and the Travel Model Improvement Program Review Panel of the Federal Highway Administration. Michael has served on the NRC Committee to Review the EPA's Mobile Source Emissions Factor Model, the Committee for the Evaluation of the Congestion Mitigation and Air Quality Improvement Program, the Committee on Air Quality Management in the United States, and the Executive Committee of the Transportation Research Board. He is the recipient of numerous awards, including the 2004 National Award for Outstanding Achievement in the Metropolitan Planning Organization.

Morris' education includes a B.A. in environmental design and planning and a M.S. in civil engineering, both from the State University of New York at Buffalo. He is a resident of Arlington.

When a consortium of leading Barnett Shale production companies founded the Barnett Shale Energy Education Council (BSEEC) in 2007, it selected Ed Ireland as executive director. Ireland and the BSEEC are dedicated to promoting energy education and best practices as they relate to oil and gas leasing, drilling, production, transportation and marketing in the Barnett Shale.

Ireland's executive management experience, operational expertise and 20-year oil and gas career made him the ideal candidate to oversee the activities of the BSEEC, and implement educational and outreach programs in the 24-county area that makes up the Barnett Shale. An industry expert, he also acts as spokesperson for the Barnett Shale, as well as a community and media representative on behalf of BSEEC members. He serves on the Board of Directors of the TCU Energy Institute and was a co-founder of the Metroplex Natural Gas Vehicle Consortium.

Ireland started his career in the energy industry as an energy economist at United Gas Pipeline in Houston. He founded Energy Planning Associates and GasMark, Inc., a natural gas supplier and pipeline company, and later became president of GeoSource, Inc., an independent oil and gas exploration company. Ireland also served as Alderman of the City of Southside Place, Texas, for three terms.

Prior to his corporate work, Ireland served as assistant professor and head of the Economics Department at Clemson University in South Carolina. Ireland holds a B.S. in economics from Midwestern State University, a Ph.D. in economics and statistics from Texas Tech University and did post-doctoral work at the University of Chicago.





Victor Vandergriff Commissioner Texas Transportation Commission

Victor T. Vandergriff is a member of the Texas Transportation Commission, which oversees statewide activities of the Texas Department of Transportation. He was appointed commissioner by Governor Rick Perry on March 26, 2013, and took his seat on the commission on April 30, 2013.

Vandergriff is an attorney and private businessman specializing in business development and legislative issues.

From 2009 to 2013, Vandergriff served as the chairman of the Texas Department of Motor Vehicles Board. He was also a board member for the North Texas Tollway Authority from 2007 to 2013 and served as chairman from 2010 to 2011.

Vandergriff formerly served as Vice President of V.T., Inc. and Automotive Investment Group, the largest private retail automotive group in the United States. He was involved as an owner, dealer and executive manager in the automobile industry for more than 25 years. Vandergriff and his family have owned and operated automobile dealerships for more than 80 years in the Dallas-Fort Worth region.

Vandergriff attended the University of Southern California, where he received a degree from the School of Public Administration in Public Affairs. He received his law degree from Southern Methodist University in Dallas.

A native of Houston, Dan Harmon comes to TxDOT from the Texas Department of Public Safety, where he has served as the Director of Facilities since the fall of 2012. Responsible for over 320 facilities statewide, encompassing more than 3 million square feet of owned, leased or shared space, he led the planning and execution effort for a \$200 million construction program and \$42 million in combined deferred maintenance funding.

Prior to joining DPS, he spent 22 years on active duty with the U.S. Navy. After earning a BA in Government from the University of Texas, he received his commission in 1989 through the Naval Reserve Officer's Training program. He has served in a variety of operations, logistics, command and staff capacities, and deployed to over 30 different countries worldwide.

Harmon's leadership experience includes three squadron tours, as Mission Commander, Instructor Pilot and Department Head, flying combat missions over Somalia, Bosnia-Herzegovina and Afghanistan. He served as Current Operations Officer for Commander Task Force 67 in Italy, where he was involved in virtually every aspect of maritime patrol and reconnaissance operations in the European Theater, and was forward deployed to support NATO peacekeeping forces on the ground in Bosnia.

In addition to his studies at UT, Harmon earned an MBA, graduating with honors, from the U.S. Naval Postgraduate School. He is also a graduate of the Aviation Safety School, U.S. Naval Test Pilot Short Course and holds certifications in financial management, test and evaluation, and program management from the Department of Defense.

Betsy Price Mayor, Fort Worth

Betsy Price, a Fort Worth native, was elected as the 44th Mayor of the City of Fort Worth on June 18, 2011.

Prior to taking the reins as the Mayor of the 16th largest city in the nation, Price served as the Tarrant County Tax Assessor. There, she transformed the Assessor's Office into one of the most efficient in the State of Texas, saving taxpayers millions of dollars. Before her life in the public sector, Price was owner of a successful title company called Price Cornelius Title.

Since taking office as Mayor, Price has initiated a broad agenda founded in the values of fiscal responsibility, accessibility, accountability and customer service. More specifically, Price continues to work with her City Council colleagues, city staff and local partners on several local initiatives, including engaging young leaders; promoting a healthy, active city; creating and retaining jobs; expanding public transit; and engaging faith communities.

She has been married to her husband, Tom, an insurance agent, for more than 40 years and has three children: Kathryn, Phillip and Paul. Price is also a proud grandmother to her four grandkids.





Oscar Trevino, Jr.Mayor, North
Richland Hills

T. Oscar Trevino, Jr., P.E. was elected Mayor of the City of North Richland Hills in June 2002 and has been re-elected six times, making him the longest serving mayor in the city's history. Prior to being elected mayor, he served as a council member for three years.

Trevino has been a tireless advocate for transportation funding throughout North Texas, serving in roles that include being past president of the North Central Texas Council of Governments, past chair and current member of the Regional Transportation Council, and past chair and current member of the Tarrant Regional Transportation Coalition. He is a member of the Coalition for Better Transportation, Texas Transportation Institute and TEX-21. He is also a member and former chair of the National League of Cities (NLC) Transportation & Infrastructure Services Committee and a member and past president of the NLC's Hispanic Elected Local Officials group. He is a member and past chair of the Mayors' Council of Tarrant County, as well as the Northeast Leadership Forum.

For his leadership in business and government, Trevino was honored as the Hispanic Businessman of the Year by the Fort Worth Hispanic Chamber of Commerce in 2015. He received the William J. Pitstick Regional Excellence Award presented by the North Central Texas Council of Governments in 2010 and was honored with the Transportation Excellence Award in Mobility from the North Texas Commission in 2008.

Trevino graduated from Texas A&M University in 1978 with a B.S. in civil engineering and is the president of O. Trevino Construction.

Mike Taylor is a lifelong resident of Northeast Tarrant County and a Colleyville resident since 1984. He has seen the change growth has had on the Metroplex. He has been a civic and community service volunteer for almost three decades in the Northeast Tarrant County area.

Taylor has a working knowledge of economic development and its impact on Northeast Tarrant County and its local businesses. Warren Robb and his wife Kathy have been residents of Haslet since 1993. A 27-year member of the TxDOT family, Barth began his career as an engineering assistant in the Dallas District after graduation from the University of Texas at Austin with a B.S. in civil engineering. In 2003, Barth was appointed as the Dallas District's director of transportation planning and development. From 2009 to 2013, Barth served as the Fort Worth District's deputy district engineer, providing joint oversight and development of the DFW Connector, North Tarrant Express, I-35W, I-30 and Chisholm Trail Parkway.

Appointed as Fort Worth district engineer in November 2013, Barth serves on the Regional Transportation Council of the North Central Texas Council of Governments working to solve Metroplex-area transportation issues. Under Barth's direction as district engineer, he also oversees over \$1 billion in construction work each year in addition to major projects on I-35W, SH 360 South, and the I-30/SH 360 Interchange.


